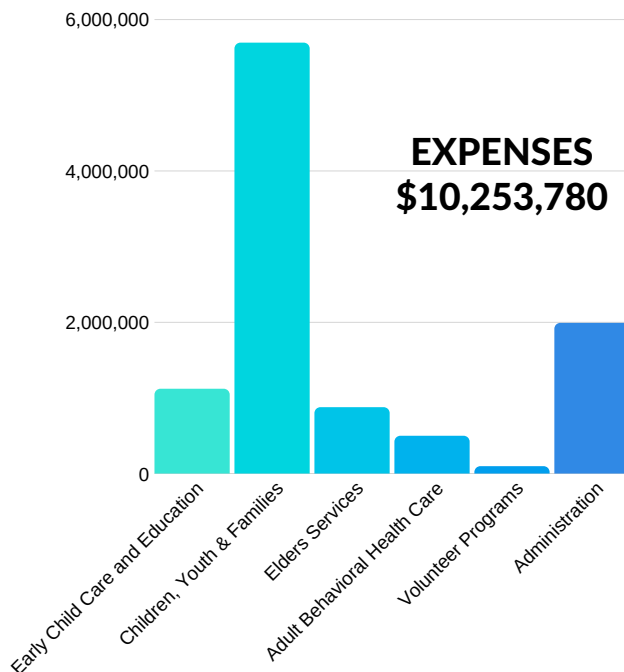
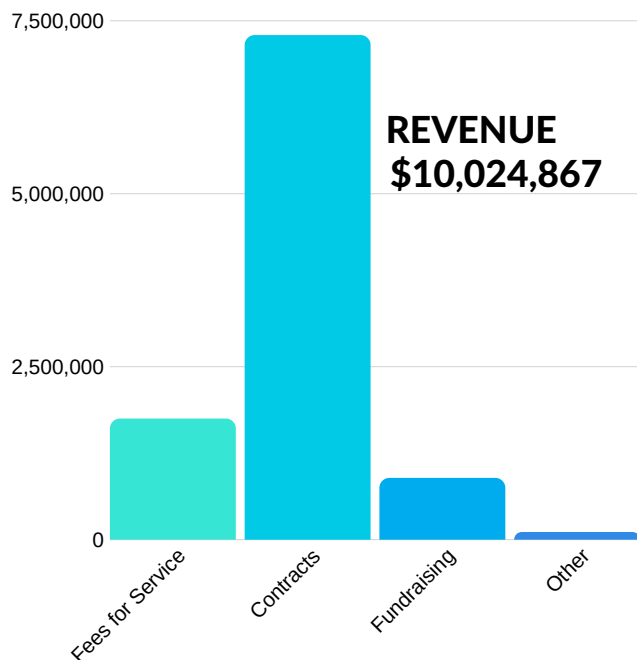

Fiscal Year July 1, 2017 - June 30, 2018



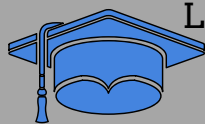
Child & Family is proud to serve nearly **5,000 Rhode Islanders** each year.
