Child & Family supports resilient families, vulnerable children, and elders throughout Rhode Island. Family Preservation is an important goal of every program and service we provide.


We believe that individuals and communities thrive when supported by strong families, and that a community works best when it accepts responsibility for all of its members

# 2019 Impact on Rhode Island



30 families in our Family Care Community Partnership (FCCP) have found permanent housing while in the program. 5,000 Rhode Islanders benefited from one or more Child & Family programs and services.



425 seniors secured health insurance coverage by working with Child & Family Medicare/Medicaid experts.





More than 50 foster children were successfully placed with loving and supportive foster families.



500 families across RI were helped through our Family Preservation programs.

802 seniors received services through Child & Family, including case management, counseling, and basic needs assistance.





Over 150 students enrolled at Sandpipers Early Learning Center. 17 homeless families were provided with a safe and nurturing place to live through our Supportive Housing program.
